#### UK

Consumer cards no longer attract card fees. We can process Visa & MasterCard credit cards, but not AMEX due to high processing fees.

We do not charge for the receipt of Bank Transfers from UK based bank accounts.

UK Corporate cards (credit or debit) will attract a fee of 3.0% - please refer to us if you intend to use a corporate card.

#### Europe (excluding UK)

If you wish to pay with a European based consumer debit card our card processor will levy a 0.5% fee. For European consumer credit cards there is a 1.0% processing fee for Visa or MasterCard. Corporate Debit Cards will attract a fee of 4.0%, Corporate Credit Cards will attract a fee of 5.0% - please refer to us if you intend to use a corporate card.

We do not charge for the receipt of Bank Transfers from European based bank accounts, based on 1 deposit and 1 balance payment being made. For additional instalments a receipt fee of €11 will be charged to the payee.

Your bank will advise the cost of the transfer; however they sometimes fail to advise that your payment may go via an intermediary for an additional charge. Please arrange that Purely Maldives receives the full balance due (after any additional fees have been deducted).

#### International (outside of Europe)

If you wish to pay with a debit card or credit card we will need to charge a 2.5% processing fee. Overseas Corporate Debit Cards will attract a fee of 4.0%, Overseas Corporate Credit Cards will attract a fee of 5.0% - please refer to us if you intend to use a corporate card.

We do not charge for the receipt of Bank Transfers from non-European based bank accounts, based on 1 deposit and 1 balance payment being made. For additional instalments a receipt fee of \$12 will be charged to the payee.

International Bank Transfers – your bank will advise the cost of the transfer; however they sometimes fail to advise that your payment may go via an intermediary for an additional charge of \$30. Please arrange that Purely Maldives receives the full balance due (after any additional fees have been deducted).

Deposit payments of \$/£/€ 200 do not attract card fees.
